(B) TEACHERS' FEEDBACK

In 2022-23 Pub Kamrup College collected teacher's feedback for assessing performances in the context of different aspects and also to adopt certain strategies for the overall improvement of the college. Findings:

1. 82% teacher respondents agreed that the syllabus is suitable for the course

2. 9% strongly agrees that the Syllabus is need based and well defined and 73% agreed for the same.

3. 36% respondents agreed that there is sufficient number of prescribed books available in the library.

4. 86% agree regarding that the course content is followed by corresponding reference materials.

5. 45% teachers agreed that the course/syllabus has good balance between theory and application whereas 36% expressed disagreement for the same.

6. Around 91% respondents expressed agreement on the issue that the course/syllabus has made hem interested in the subject area.

7. 91% agrees that the course/syllabus increased their knowledge and perspective in the subject area.

8. 73% responds agreethat books prescribed/listed as reference materials is relevant, updated and appropriate.

9. 18% strongly agrees, 63% agrees and 9% disagrees that the Infrastructural facilities, such as teacher's room/carrels, classrooms, reading rooms, toilets, etc. are available in the department.

10. 36% teacher respondents agreed that the Laboratory facility provides sufficient scope for syllabus-oriented practical whereas 40% expressed neither agreement nor disagreement for the same statement.

11. 54% and 45% respondents strongly agreed and agreed about the availability of Canteen facility at the college premise.

12. 36% strongly agrees that the Tests and examinations are conducted well in time with proper coverage of all units in the syllabus and 59% agreed for the same.

13. Around 64% teacher respondents strongly agree that they have the freedom to adopt new techniques /strategies for teaching such as seminar presentations, group discussions and learners' participation.

14. 59% strongly agrees that they have the freedom to adopt/adept new techniques/strategies of testing and Students' performance and 9% expressed disagreement.

15. 18% strongly agrees, 59% agrees and 9% disagrees that the environment in the department is conducive to teaching and research.

16. 27% strongly agrees and 68% agrees that the administration is teacher friendly.

17. 64% agrees that the college provides adequate and smooth support for projects and research facilities.

18. 36% strongly agrees, and 50% agrees that the college provides opportunities to faculty members for upgrading their skills and qualifications.

19. 27% strongly agrees, 59% agrees that the provisions for professional development are non-discriminatory and fair.
