4. Electricity and water facilities are not connected.
5. Fire fighting devices are not present. Playground is not ready. Boundary is not present.
6. All weather approach road is not constructed.
7. Library, computer center, multipurpose halls and classrooms are not ready.
8. Rainwater water harvesting kitchen garden are not available.
9. Toilets for boys, girls and for physically challenged people are not ready. Ramps is not ready and not connected.
10. The institution in the present condition is not accepted.
11. New building is under construction and is not finished.
12. The adequate books in library, Title of Books, Professional Research General is required.
13. Education Encyclopedia, Electronic Publication, Digital or Online Resources are not available with the institution
14. Science Stream Laboratory, Humanities Stream Laboratory, Activity cum Resource Centre, Health and Physical Education Room, Faculty Room, Administrative Office Space, Common Room, Store is not available with the institution.
15. Adequate furniture is not available
16. Safe Drinking Water, Electric Arrangement of Clearing of Campus, water and toilet are not available.

- As per decision of ERC, Inspection was made.

After carefully observing the online application form, VT report along with other related documents, the ERC found the following:

1. The institute does not have adequate classrooms for the courses offered.
2. The institute has not purchased a single journal for the proposed course. Although the institute already offers a B.Ed. course, it is still not purchasing any academic journals.
3. The institute has not purchased books for the proposed course.
4. The Multipurpose Hall of the institute is not as per the standards set by NCTE.
5. The institute does not have a single Education Encyclopedia.
6. The Science Stream Laboratories of the institute are not as per the standards set by NCTE.
7. The Humanities Stream Laboratories of the institute are not as per the standards set by NCTE.
8. The Total Built Up Area mentioned in the building plan (in sq m) of the institute is 1470.71068 which is not as per the standard set by NCTE.
9. The NON-ENCUMBRANCE CERTIFICATE of the institute is issued on 25/05/2022.
10. The Built-Up area mentioned by the institute in the Affidavit is (in sq m)-1470.71068 which is much less than the standard set by NCTE
11. Institute Building Safety Certificate is not Available
12. The institute building is G+2 but there is no lift and ramp facility available for commuting to the first and second floors of the building
13. The institute does not have a Fire Safety Certificate.
14. The design and construction of the Institute building are completely different.
15. In the No Objection Certificate No. 20 received by the institute from the State Government, permission has been granted for only 01 unit each of B.A. B.Ed. and B.Sc. B.Ed. but the institute has demanded 08 units which is not justified.
16. The built-up area of the institute is insufficient and does not fulfill the minimum requirements mandated for B.Sc. B.Ed. and B.A. B.Ed. courses.
17. There is no lift or ramp facility to access the upper floor, which fails to provide a barrier-free environment for physically challenged people.
18. The drawings and the actual infrastructure do not match, and the area mentioned in the completion certificate is also inconsistent.

Hence, the committee decided that the show cause notice be issued to the institution to submit the reply through the portal on the deficiencies mentioned above within 07 days from the date of issue of the show cause notice.

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- First SCN was issued to the institution on 17.10.2023 and Final SCN was issued to the institution on 21.02.2025. The institution has submitted reply on 06.03.2025

After carefully observing the reply to the final show cause notice, the ERC concluded the following:

1. The institution has appointed only one teaching faculty of Fine Arts, music and Physical Education whereas there is the requirement of two teaching faculty each for Fine Arts, Music and Physical Education.
2. The several teaching faculties appointed by the institution is matching with B.Ed., M.Ed. and D.El.Ed. programme each other's which is not acceptable as per NCTE Regulations.
3. The total land area is 3724 sqmts as per CLU which is less than for running four-unit B.Ed. course, one unit D.El.Ed. course and one unit M.Ed. course.
4. The total built up area is 4774.56 sqmt for running four-unit B.Ed. course, one unit D.El.Ed. course and one unit M.Ed. course which is less than the requirement under NCTE Regulations amended from time to time.
5. The institution has not submitted approved Building Plan with course wise earmarked area for proposed course and existing course.
6. The institution has not submitted latest NEC issued by the Competent Government Authority.

Hence, Committee decided that the recognition granted to the institution for running B.Ed. M.Ed. and D.El.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

1. The guidelines for "Transforming NCTE Recognized Stand-Alone Teacher Education Institution into Multidisciplinary Higher Education Institutions" issued by the NCTE in May, 2025 is applicable to the instant matter as the institution is not multidisciplinary as defined under NCTE regulations amended from time to time.
2. The institution has now submitted a Memorandum of Collaboration between **AL HILAL MISSION TEACHERS TRAINING INSTITUTE** and **KANDI RAJ COLLEGE** executed on 04.11.2025.
3. The institution is required to submit a proof to the effect that both the institutions are within a distance of 10 km.
4. Both the institutions intending for such collaboration must be affiliated with the same university. In the instant matter, different universities exist, which is not acceptable.
5. The institution is required to produce a certificate from the concerned State Government justifying the need for teacher education programme in that area/region.
6. The institution is required to submit a proof to the effect that the affiliating university, through its statutory body, approved the collaboration.
7. The institution is required to submit a proof to the effect that **KANDI RAJ COLLEGE** are offering at least two undergraduate degree programmes in accordance with the requirements of ITEP and it has no Education Department of its own.
8. The institution is required to submit a proof to the effect that **KANDI RAJ COLLEGE** has collaborated only with **AL HILAL MISSION TEACHERS TRAINING INSTITUTE** for making the latter as a multidisciplinary institution.

Hence, the committee decided that the show cause notice be issued to the institution to submit the reply through the portal on the deficiencies mentioned above within 15 days from the date of issue of the show cause notice.

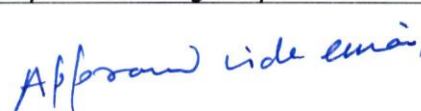
