### Conditions to be fulfilled for affiliation of the Course:

1. The College / institute must adhere to UGC Norms for opening of new colleges and courses. The UGC (Affiliation of Colleges by University) Regulations, 2009 published vide UGC Notification No F.1-7/2007(CPP-1) dated 29<sup>th</sup> April, 2010 and subsequent addendum and corrigendum will be applicable for all aspects.
  2. This affiliation is provisional for (2) **two** years, subject to the approval of Executive Council of the University. The university may conduct inspection visit to institution from time to time as it deems fit. Based on the report of inspection visit the university may allow renewal of affiliation or any other action as deemed to be fit.
  3. Renewal fees for affiliation will be charged per course as per the University rules after every 2(two) years. The permanent affiliation can be considered only after the accreditation of NAAC/ NBA and as per UGC and ASTU guidelines.
- The Institute must comply to Anti-Ragging Regulation of UGC/AICTE.  
The Governing body of the college must have two members from the University.  
Admission in a particular batch should not be less than 50% of the approved intake capacity. If admission is less than 50% of the approved intake capacity, then the institution will have to pay additional fee to meet up the various fee for 50% of student intake.



4. Separate classrooms and lab should be provided for the students of P.G courses.
5. The institute is suggested to submit short and long academic plan for improvement of quality education.
6. Fees to be deposited on or before 27<sup>th</sup> June, 2020.
7. Paying of affiliation fees shall be considered as acceptance of all terms and conditions.
